- Coming Events – Pairs Championships, Under 50, Novice / Restricted. Entries open on MyABF. Email sent to all Members with a link to each entry
- RAMP Program – further discussion required
- Monday morning session – email received about changing time. Time has changed 3 times. A vote was issued last year to all Monday morning players, 39 responded and 56% were in favour of 9.00 am start. Year to date – Monday morning 7% and Monday afternoon 6%. The Committee voted to leave the time of both Monday sessions unchanged.
- TBIB – Insurance and Sponsorship. Despite earlier promises, no sponsorship funds have been received. As a result, their logo will be removed from all marketing materials. - Leaf Catchers – Greg Sultzberger has installed 3 leaf catchers on the downpipe. Also, has cleaned the back gutters and will start cleaning the front. Greg has offered to clean the gutters every quarter. We thank Greg for all his maintenance work.
