General Business:

- Update from Graded Pairs Congress
 - 36 Pairs. 3 Grades. All went well. Plenty of volunteers to help in the kitchen, which was great to see.
- Update from Zone AGM
 - 6 Clubs in Sunshine Coast. Zone Graded Pairs on 24th November. Dates agreed for GNOTs. Moreton Bribie historically had two GNOT's this has changed to 1 per annum. From 2026 Noosa will hold their GNOT's over a weekend.
- Update from QBA Zoom Meeting
 - o Proserpine BC closing. Members going to Bowen
 - Cleveland merging with Townsville BC
 - 2025 last year of GC Congress, filling up fast, enter early. Nothing in 2026. Planning for 2027 possibly smaller.
 - Profit from GC Congress \$38k without this QBA would make approx. \$10k loss
 - o Jan Peach successful Director's seminar. Next one 27th Sept 2025
 - Sponsorship Fixed Income very generous. 12 clubs made contact and all received support
 - o MyABF membership admin ready to launch. Masterpoints priority next year
 - GNOT's to discuss format for 2025

- Update Melbourne Cup
 - 17.5 tables. Very successful day. Plenty of food. Not many people dressed up. Photos will be put on the website.
- Calendar 2025 in Progress New Caloundra Shield > 50 PMs 8th July. The onus is on Members to inform the Club when their contact details change.
- Red Point Days in 2025 increased to 28 from 26
- Sponsorship Feb 22nd Pairs and Feb 23rd Teams. July 8th Caloundra Shield. TBIB very professional, focused on sponsorship. Meeting arranged for Monday 25th November at 2pm. Fixed Income interested, offer \$750. They request a table set up on the day and do presentation. Propelled Financial Solutions offer \$750. Meeting to be set up.
- Membership 2025 My ABF facility to collect money via Bridge Credits. Home \$66.60. Away \$20. Home Club outside QLD \$43.30. The Committee has agreed to use MyABF to collect membership fees on 15th January 2025. Individual exceptions to be considered. Emails to be sent to all members in advance.
- Tables Fees last increased 2021. Planning for the financial viability of the Club into the future, the Committee have agreed to increase the table fees to \$7 and \$9 for visitors with effect from 1st July 2025. Proposed by Kerry Thorp. Seconded by Janie Brennan. Carried. Local Bridge Clubs have expressed concern about their financial situation and have increased their table fees, also many Clubs have a higher annual membership fee than Caloundra.
- Director's Computer network issues becoming a regular problem. An issue on Melbourne Cup
 Day connecting to the screen. New computer in the region of \$1,500-\$2,000. Proposed by Kerry
 Thorp. Seconded by Greg Dobson. Carried.
- MasterPoints restricted promotions. It is the responsibility of the player to check their MP's at
 the end of each month and ensure eligibility to play in restricted sessions. If players reach 50
 MP's during the month they can play until the end of that month.
- Operation of Fans in warm weather the fans will be turned on at all sessions. The operation and adjustment of fans is the sole responsibility of the Director on the day.
- Christmas Party Judy Leathley has volunteered to organise the event this year. Two outside ladies will assist in the kitchen. It is essential for catering purposes when members put their name on the list to bring something – that's what they bring. We are looking for players to provide entertainment. Friday 6th December 2024.
- Teams of 3 disappointingly very little interest so far. Bob Davies to speak to Tuesday session and send out email.
